EXPRESSION OF INTEREST DOCUMENT

Sub:

Expression of Interest (EOI) for empanelment of honey bee boxes/colonies and stand, related equipment Manufacturers /Organizations under the Apiculture Development Schemes of the Department for the year 2022-23.

PREAMBLE:

The Karnataka State Department of Horticulture invites the Expression of Interest (EoI) through e-Procurement to empanel manufacturers of honey bee boxes/colonies and stand under the Apiculture Development Schemes of the Department of Horticulture for the year 2022-23.

This EOI is governed by the following Terms and Conditions (set out under different Heads as under)

- 1. The Manufacturer shall submit proposal of EoI as per Annexure- I. The Manufacturer shall upload all the details along with relevant Documents separately through e-Procurement website https://eproc.karnataka.gov.in.. Those who are already empanelled during 2021-22 and whose operation period is up to 31.03.2023, need not apply for empanelment now.
- 2. The proposals will be opened in the office of the Additional Director of Horticulture (Oil Palm).
- 3. Every correction in the documents shall be attested by the Manufacturer, otherwise it will be rejected.
- 4. The EoI document must be signed only by the proprietor, if it is a proprietary concern. If it is a partnership firm, one of the Partners duly authorized by the firm shall sign the EoI document. Attested copy of the Partnership Deed and authorization letter for signing of EoI documents, with necessary seal and signature shall be submitted through e-Procurement portal.
- 5. If the information and document uploaded is incomplete in any form, it will be out rightly rejected. Care must be taken to fill the form and details must be provided as required.

6. Bank Guarantee

- Performance Bank Guarantee of Rs.25,000/- (Rs. Twenty Five Thousand only) valid for a minimum period of one and half year (up to 31.09.2023).
- Bank Guarantee shall be uploaded in the e-procurement portal. The Bank Guarantee of the successful Manufacturer will be retained by the Department as security deposit and will be returned after the validity period of the EOI or shall be forfeited in the event of violation of EOI terms and conditions.
- The Bank Guarantee of unsuccessful manufacturer will be returned after completion of the EOI process or in the event of cancellation of EOI process.

7. Validity of EOI

- The operational period of a successful empanelled manufacturer is valid for a period upto 31st March 2023. The extension of operational period of further vests with Director of Horticulture, GoK depending on the requirement.
- The empanelled manufacturer shall supply the bee boxes, colonies and related equipments as per the rates quoted in the empanelment registration document.
- There shall not be any upward revision of rates during the validity period of EoI /or during the operational period of empanelled manufacturer.

8. Qualification, Roles and Responsibilities of Manufacturers

8.1 While empanelling the manufacturers, the following aspects shall be ensured:

- 8.1.1 The manufacturer/ organization must manufacture / produce honey bee boxes and colonies. If the company /organization are manufacturing only bee boxes then they should procure quality colonies from bee breeders/apiary owners and supply them as one unit to the beneficiary. Necessary documents to be uploaded in this regard.
- 8.1.2 The companies shall supply honey bee boxes/ colonies and stand, related equipments as per the approved rates (Annexure-II) and technical specification (Annexure-II A) only.
- 8.1.3 The manufacturer should have a minimum business turnover of Rs. 4.00 lakhs per annum for the last three consecutive financial years and should have sold at least 200 number of honey bee boxes/ colonies per year. Original copy of CA certified Statement of Accounts to be enclosed.
- 8.1.4 They shall agree to the approved rates and Technical Specifications for honey bee boxes/ colonies and stand (Annexure-II and IIA) by the Department. Only those manufacturer/companies/organizations/units who agree to this condition may apply.
- 8.1.5 The registration will be normally valid for the period 2022-23 ending on 31.03.2023. The Director of Horticulture, GoK reserves the right to restrict/extend the period of registration with or without assigning any reason.
- 8.1.6 The manufacturer shall download EOI documents through e-procurement website https://eproc.karnataka.gov.in from 24.06.2022 to 22.07.2022 and last date for submission of EOI in e-portal is 22.07.2022.
- 8.1.7 The area of operation will be for entire State. If a manufacturer/organization has limited resources for supply of bee boxes, colony and stand, manufacturer/organization can restrict area of operation accordingly to the part not less than 3 districts. The final decisions on allocating area of operation of any company /organization lies with the department.
- 8.1.8 The manufacturer shall submit a bank Guarantee, of Rs.25,000/- (Rs. Twenty Five Thousand only) valid up to 31.09.2023. The Department reserves the right to modify the value and period of Bank Guarantee if it deems fit.
- 8.1.9 The manufacturer is required to furnish a self-certificate certifying that they are not black listed in any Central/State Govt., or their instrumentalities as on date of downloading of bid documents.

8.2 Roles and responsibilities of Manufacturers

- 8.2.1 The honey bee boxes/ colonies, stand and other related equipments shall be supplied to the interested beneficiary directly by the manufacturers/organisations. The manufacturers /organizations shall authenticate the invoices, bills and specifications by following all the Statutory Laws and Rules.
- 8.2.2 The manufacturer/organization themselves may assist the beneficiary in submitting records and bills to the Implementing officer for the purpose of obtaining assistance under the scheme.
- 8.2.3 In the event of any damage to parts of the bee box/ stand, related equipment before handing over to the beneficiary, it shall be replaced.
- 8.2.4 The manufacturer shall take the responsibility for any disputes arising from the sale of honey bee boxes/ colonies and stand, related equipments to the farmer. The manufacturer shall resolve the issue. The Department of Horticulture shall take no responsibility of resolving the issue arrived out of sale between manufacturer and farmer. The responsibility of resolving the issue with the farmer is completely with the manufacturer.
- 8.2.5 The Department is free to take strong punitive measures including and not limited to forfeiting of bank guarantee/ security deposits, blacklisting against erring companies/manufacturer, in order to safeguard the interests of beneficiaries and to ensure effective utilization of public funds.
- 8.2.6 The warranty/guarantee for the bee box/ stand shall be at least 3 years from the date of handing them over to the beneficiary by the manufacturer. If any parts of bee box/ stand found to have manufacturing defect or poor workmanship within the warranty period, they shall replace the same free of cost.

8.3 Quality Control measures

- 8.3.1 Frequent surveillance by inspection teams comprising officials from Department of Horticulture, will be taken up. The random samples will be drawn and checked.
- 8.3.2 In case of detection of supply of poor sub-standard quality bee boxes/stand, related equipment, the concerned manufacturer/organization will be issued warning to replace substandard quality with the satisfactory good quality for the first offence. In case of subsequent offences, the Company will be deempanelled and restricted from participating in the said Scheme, in addition to invoking of bank guarantee. Also, the manufacturer shall pay back entire amount to the beneficiary.
- 8.3.3 In case of any dispute in quality, the aggrieved shall appeal to the district level officer. The Deputy Directors shall resolve the dispute arised between manufacturer and the beneficiary. If issue is not solved at the district level, the aggrieved may appeal to the respective Head of the Departments. The decision of the Head of the Department will be final.
- 8.3.4 The representatives of the Department, Government of Karnataka will have the authority to inspect any manufacturing unit or go-downs to draw samples and test them at any time during the appropriate period. If any defects are found, manufacturing company will be disqualified.

9. Technical Specifications

The following points shall be considered by the manufacturers/organisation while implementation of the scheme.

- a. Good quality bee boxes having Technical Specifications as per the ISI A standard (boxes of 8 frames for <u>Apis cerana</u>) made of Forest wood and frames made of teak/honne/matti are to be supplied. Boxes should have both family chamber and Honey/super chamber. Details of dimension of different components of the boxes as per ISI A standard is enclosed in Annexure-II B.
- b. Each colony of <u>Apis</u> <u>cerana</u> should have minimum of 4 full frames of healthy worker bees and one fertile healthy and young queen bee.
- c. The stand should be made of Iron and size should be suitable to keep the ISI A standard bee box. (Annexure II C).

The important aspects of mode of implementation has been briefed in Annexure-III, the manufacturers shall adhere to it.

10. Opening and scrutiny

- 10.1 The opening of the technical proposals will be taken up in the presence of EOI Technical Advisory Committee / scrutiny committee. Manufacturer or their authorized representatives may be present at that time. The scrutiny will be conducted by the EOI scrutiny committee/ Technical Advisory Committee, in the office of Additional Director of Horticulture (Oil Palm), Lalbagh, Bangalore-04.
- 10.2 EOI not accompanied by the following items that are uploaded in the e-procurement portal will be rejected.
 - Bank Guarantee specified.
 - Details of Firm registration (Copy of Registration/ Partnership/Sole Proprietorship/MSME Udyog Aadhar Registration/ SSI Certificate)
 - Certificate of GST, PAN No, Aadhar No.
 - Registration fee details
 - Audited Annual Turnover statement of previous three financial years .(2019-20, 2020-21 and 2021-22)
 - GST Certificate of recent two months paid.
- 10.3 The EOI shall be rejected, if the manufacturer is a defaulter in the previous transactions or Government supplies.
- 10.4 EOI scrutiny committee/ Technical Advisory Committee will recommend for acceptance or rejection of the EOI/ Manufacturer to the EOI Accepting Authority viz., Director of Horticulture, GoK.
- 10.5 The Manufacturer if disqualified at any stages of EOI process will not be given any intimation by writing or in any manner.

11. Award of EOI

- 11.1 After the scrutiny, the Department of Horticulture, if convinced on supply of quality materials as per the specifications will consider for empanelment and will issue orders duly approving the qualified Manufacturer.
- 11.2 Manufacturer shall enter into an agreement (MOA) within 15 days from the date of approval of the Manufacturers.
- 11.3 If the materials are not supplied as per the specifications mentioned will be treated as violation of the EOI document.
- 11.4 The empanelled manufacturer receiving the beneficiary share/Govt. subsidy shall bear the bank charges.
- The manufacturer shall pay registration fee of Rs.5,000/- which is nonrefundable through online - (k2.karnataka.gov.in) Khajane 2. Challan Generation and payment to be made to HOA: 0401-00-119-0-04-000 (Receipts from Horticulture and Vegetable crops & other items). After online payment download the PDF of Customers and Bankers copies for print and submit the copies to Bank. After getting transaction number from the Bank, submit the original challan to the office of Additional Director of Horticulture Palm), Lalbagh, Bengaluru- 04 and upload the same e-procurement portal, without fail. Otherwise manufacturer/company/organization shall not be considered for empanelment.

12. Delivery and Document procedures:

- 12.1 The farmers are free to buy the bee boxes and related equipments from any of the empanelled manufacturer at the approved rate, based on his interest and requirement. After the purchase, the farmer shall submit the application for claiming subsidy in the prescribed format with all the necessary documents to the concerned taluka Senior Assistant Director of Horticulture, (ZP).
- 12.2 The manufacturer shall not bring any pressure/influence on farmers to buy bee boxes and related equipments from his organization /company.
- 12.3 The empanelled manufacturer can directly sell the approved quality equipments to farmers.
- 12.4 The subsidy will be sanctioned and released as per the guidelines of the Department issued from time to time depending on availability of funds.
- 12.5 The empanelled manufacturer shall submit the statement of sale/supply of bee boxes/colonies and stand, related equipments to farmers on monthly basis to Asst. Director of Horticulture(Apiculture), Lalbagh, Bangalore.

13. Penalties for Non-compliances, violations and Non-performance:

13.1 Punitive action includes and are not limited to warning, penalty of Rs. 10,000/- or above, forfeiting of bank guarantee, black listing and legal action depending on the gravity of the fault/offence, any one or more than one punitive action may be imposed at a time.

Under following circumstances punitive actions will be imposed.

- a) If the **bee boxes, colony and stand** sold/ supplied by the manufacturer does not meet to the approved Technical Specification if the **bee boxes, colony and stand** is of bad quality or if found billing higher price for the same. In such cases, the Company will be de-empanelled and restricted from participating in the empanelment of the departmental scheme in addition to invoking of bank guarantee. Also, the manufacturer shall pay back entire amount to the beneficiary.
- b) Manufacturer/organization raising false bills without supplying and/or violating any norms/rules/ guidelines will be penalized.
- c) If it is found that false documents are submitted at the time of registration, the registration of such companies/organizations will be cancelled, blacklisted and their bank guarantee will be forfeited.

14. Legal Terms and Compliances:

- 14.1 The manufacturer shall execute an agreement covering all the Terms and Conditions on a judicial stamp paper (purchased in the name of the Manufacturer) of Rs.200/- or as per the existing procedure at his cost within 15 days from the date of approval of the Manufacturer. The manufacturer is not permitted to supply the items without execution of the agreement.
- 14.2 In respect of any dispute arising out of implementation of this EOI, the decision of the EOI Accepting Authority shall be final.
- 14.3 For any legal remedies, the courts of Bangalore shall only have the jurisdiction.

15. Rights reserved:

- 15.1 The decision of the EOI Accepting Authority/Director of Horticulture shall be final for considering or rejecting of any manufacturer/ equipment of the manufacturer.
- 15.2 The Department of Horticulture reserves the right to accept or reject the EOI at the time of processing, finalization, even after finalization and during operational period of registration without assigning any reasons whatsoever.

- 1. I shall supply good quality bee boxes having Technical Specifications as per the ISI A standard (boxes of 8 frames for <u>Apis cerana</u>) made of Forest wood and frames made of teak/honne/matti, having both family chamber and Honey/super chamber (Details of dimension of different components of the boxes as per ISI A standard as enclosed in Annexure-II B).
- 2. I shall use well-seasoned durable wood for making the bee boxes.
- 3. I shall supply bee boxes where the frames of the box are made of teak or similar wood and the corners of the boxes are joined by Dove tail joint. Plywood will not be used for any part of the box. The wood used for making the outer side of the box shall be joined together by Dove tail joint.
- 4. Single piece of wood will be used for making the bottom board and also the top cover. If two pieces are used they shall be joined together by dove tail joint. Plywood will not be used for this.

Mode of Implementation

- The interested farmer shall submit application for subsidy to bee boxes, colony and stand, related equipment along with all required documents to the concerned Senior Assistant Director of Horticulture office.
- The concerned officer/staff will verify the records and after scrutiny provide the list of empanelled supplier to the farmers and ask him to purchase from any of the empanelled agencies depending on the availability of funds.
- The organization /company selected by the farmer shall sell the bee boxes, colony and stand, related equipment to farmer by adhering to the quality norms only.
- The organization/company shall provide the specified documents to the farmer (Invoice, delivery note).
- The beneficiary/ farmer shall submit the application for subsidy along with required documents to the concerned Horticulture office.
- The implementing officer along with expert shall check the size and quality of bee boxes/colony and take necessary action to provide the subsidy.
- The subsidy will be sanctioned and released as per the guidelines of the Department issued from time to time depending on availability of funds.
- The department officers shall ensure display of Name board outside the Madhuvana by the beneficiary as explained in the guidelines.
- The funds allocated will be category wise [special component sub plan (SCSP), Tribal sub plan (TSP), small-marginal farmers (SFMF), women farmers and other farmers]. Therefore, due preference should be given to such categories as per GOI and GoK norms.
- The department officers shall do random checking to test the quality of bee boxes produced by the empanelled organization at any time.

Terms and conditions for Empanelment to supply of Bee Boxes, colonies, stand and other related equipments to farmers.

1. The manufacturer shall supply Good quality bee boxes having Technical Specifications as per the ISI A standard (boxes of 8 frames for *Apis cerana*) made of Forest wood and frames made of teak/honne/matti. Boxes should have both family chamber and Honey/super chamber.

- 2. Details of dimension of different components of the boxes as per ISI A standard as enclosed in Annexure-II B of empanelment document.
- 3. The manufacturer shall supply each colony of *Apis cerana* having minimum of 4 full frames of healthy worker bees and one fertile healthy and young queen bee.
- 4. The manufacturer shall supply stand made of Iron and size suitable to keep the ISI A standard bee box. (As per Annexure II C of empanelment document)
- 5. The manufacturer shall Agree to the approved rates and Technical Specification for honey bee boxes/ colonies and stand (Annexure-II and II A, B & C) by the Department (As mentioned in Bee box, colony and stand Empanelment Notification.
- 6. In the event of any damage to parts of the bee box/ stand before handing over to the beneficiary, it should be replaced.
- 7. The manufacturer shall take the responsibility for any disputes arising from the sale of honey bee boxes/colonies and stand.
- 8. The Manufacturer shall submit details of Firm registration and other statutory documents.
- 9. The Department is free to take strong punitive measures including and not limited to forfeiting of bank guarantee/ security deposits, blacklisting against erring manufacturers in order to safeguard the interests of farmers and to ensure effective utilization of public funds.
- 10. The warranty/guarantee for the bee box/ stand shall be at least 3 years from the date of handing them over to the farmer by the manufacturer. If any parts of bee box/ stand is found to have manufacturing defect or poor workmanship within the warranty period, they shall replace the same free of cost.
- 11. Frequent surveillance by inspection teams comprising officials from Department of Horticulture, will be taken up. The random samples will be drawn and checked.
- 12. In case of supply of poor sub-standard quality bee boxes/stand, the concerned manufacturer/organization will be de-empanelled and restricted from participating in the supply process, in addition to invoking of bank guarantee. In addition the manufacturer has to pay back entire amount to the beneficiary.
- 13. In case of any dispute in quality, the aggrieved may appeal to the district level officer, and then to the respective Head of the Department. The decision of the Head of the Department will be final.
- 14. The representatives of the Department, Government of Karnataka will have authority to inspect any manufacturing unit/go-downs of manufacturers to draw samples and test them at any time. Any defects found will lead to disqualification of that manufacturing company.
- 15. The manufacturers should not deviate from the approved price for the bee boxes, colony and stand under Department schemes. In case the manufacturer is found billing higher price, such manufacturer is liable for stringent action, penalty up to Rs.10,000/- per case and / or blacklisting the company.
- 16. If the manufacturer is blacklisted by any State / Central Govt. or their instrumentalities, they are liable for rejection at any time.
