- Exporter must submit the application along with all the necessary details and documents to the office of Director/ Commissioner of Horticulture, Lalbagh, Bengaluru.
- 3. Exporter should submit Letter of Credit (LC) containing LC number, date of issue, Item name, Quantity and amount and the price quoted for Bangalore Rose Onion.

- 1. Licenced Exporter must submit the application along with all the necessary details and documents to the office of Director/ Commissioner of Horticulture, Lalbagh, Bengaluru.
- 2. Freight on Board (F.O.B) value excluding freight charges and separate Freight Charges (FC) needs to be furnished.
- 3. Only after furnishing the application along with all the necessary documents exporter will be eligible to register and get the certificate from the Director/Commissioner of Horticulture and same will be forwarded for the physical verification at the Chennai Port.
- 4. As per the Government of India notification, Dated: 09-10-2020, the export of Bangalore Rose Onion from Chennai Port will be allowed upto the maximum quantity of 10,000 MT till 31st March 2021.
- 5. Eligibility of the exporters in issuing the certificate will be at the discretion of Director of Horticulture.

Do's

- 1. DGFT Registration details, Export License Registration No., Import Export Code (IEC) No., Letter of Credit (LC) no., GST details should be verified.
- 2. Original Letter of Credit (LC) has to be verified.
- 3. Should verify the unique morphological characters (as per check list) of the produce (Bangalore Rose Onion) before packing and during exit of the port to certify the item and quantity of Bangalore Rose Onion to be exported from Chennai port.
- 4. The quantity of the Bangalore Rose Onion being exported has to be verified at the Chennai Port.
- 5. Name and address of the consignee should be verified.
- 6. Should abide to the Rules and Regulations of the Department of Customs, Chennai.
- 7. Bangalore Rose Onion grown in Chikkabalapura and Kolar districts of Karnataka State should only be allowed for the export.

Don'ts

- 1. Adulteration of other onions should be avoided with the Bangalore Rose Onion.
- 2. Only quality Bangalore Rose Onion has to be exported from the Chennai Port.

All care should be taken not to include any other onion except Bangalore Rose Onion in containers.
